I JUST RECEIVED YOUR PACKAGE MAILED ON JAN 24TH, 03. THANK YOU. SINCE BEING MOVED ON THE 9TH, I HAVE NOT BEEN ALLOWED ANY (NO) CONTACT WITH ANYONE OR ANYTHING OTHER THAN THREE OR FOUR LETTERS SENT BY FRIENDS. YOUR'S BEING THE MOST RECENT. I DON'T KNOW EVEN WHAT THE DATE IS, BUT I DO KNOW IT IS THE FIRST TUESDAY IN FEB. (NO TV, RADIO, NEWSPAPER, OR PHONE.)

I HOPE YOU & THE FAMILY ARE DOING WELL AND ARE HEALTHY. PLEASE GIVE THEM ALL A HUG FOR ME. PLEASE CALL [REDACTED] & [REDACTED] AND SAY HI FOR ME. I HAVE WRITTEN THEM, BUT IT WAS LATE IN JAN. ALTHOUGH I WAS ALLOWED TO WRITE MY "PROPERTY" FROM S.D, DIDN'T GET TO ME UNTIL THE THIRD WEEK OF JAN. (IT HAD MY STAMPS & ENVELOPES.)

I HAVE READ ALL OF THE MATERIAL YOU SENT. THE E-MAIL FROM [REDACTED] WAS I THINK HONEST & POSITIVE, BUT IS HE MY ONLY SUPPORTER OR IS HE SOMEONE I SHOULD KNOW? THE ARTICLE BY MILLS ON "LIE DETECTORS" WAS INTERESTING, BUT MUCH OF IT I HAD READ OVER THE YEARS. HOWEVER I DID NOTICE THAT THERE WAS INFO ON MY "LIE DETECTOR" TEST ON THE NET. I CAN ONLY ASSUME THAT THE POLICE RELEASED MY RESULTS TO THE PUBLIC

WHICH ~~WAS~~ SHOULD HAVE BEEN THAT I DID TAKE A TEST AND "REDIN" SAID I FAILED. BUT THEN A COUPLE OF DAYS LATER THEY DISCOVERED THAT MY TEST CONTAINED WHAT DET.
